# Greece Permanent Residency Program Golden Visa

#### REQUIREMENTS

- Purchase a property of at least €250.000 (new or resale)
- Issuance of a Greek Tax Registration Number (ΤΙΝ-ΑΦΜ)
- 4 photos for each family member
- Copy of the applicant's passport and every family members
- Marriage and Birth Certificates where applicable
- Medical Insurance

### BENEFITS

- Fast Track Procedure Approx. 3 months
- Eligibility for all family members
- Renewal of the Visa every 5 years
- Visa Free travelling to all EU and Schengen zone
- No obligation to reside in Greece
- Entitled to Rent out the Property
   & Receive return

# Important information:

- 1. A family member includes the Applicant's wife/husband, their children, Applicant's parents and parents in law;
- 2. Unmarried partners are not entitled to the Permanent Residence Permit (PR);
- **3.** PR holders have access to public education health care equivalent to that of the Greek Citizens:
- 4. The applicant's children who have originally been admitted to the country under the terms and requirements of the Golden Visa program, are provided with a residence permit for family reunification until the age of 21, provided that they are unmarried. After that, they can apply for a renewal in the form of an independent residence permit until they reach the age of 24 and then it is possible to renew it further according to pertinent immigration legislation;
- 5. Entitled to purchase a car in Greece with Greek license plates;
- 6. Entitled to take a mortgage on the property bought;
- 7. The property acquired for the investment is permitted to be rented, thus receiving return;
- 8. The amount of EURO 250.000 does not include value added tax;
- 9. The investment maybe consisted of a combination of commercial and residential property including a plot of land;
- 10. The PR does not allow the applicants to work in Greece, but can be a Shareholder in a Company and received shares/bonds;
- 11. Family members are not obliged to submit their application for their PR at the same time as the investor, and can apply at a later stage;
- 12. Biometrics apply to applicants over 6 (six) years of age and the Digital Signature to applicants over 12 years of age.
